

Modes of Study

There are two modes of study at Project Controls International Business School (PCiBS).

Online education

Students follow a standard study path. Here at PCiBS we are passionate about online study! We believe that if you need guided online classroom support, then Online Study is the way to go.

When selecting the online mode of study for your subjects or program, you can visit your online classroom anywhere, 365/24/7. The online study environment gives you access to your study materials through your online student portal where you will have access to the resources, discussions, and online forums that you have enrolled in.

Online education means that you must keep up with the class assignments as they are handed out periodically.

Distance education

Students can enroll for distance study at PCiBS. Distance students must abide by the prescribed works in their study guides and submit assignments on specified dates and time. Students doing distance learning must be able to apply diligent discipline to keep up with the work and be able to work on their own.

When selecting the distance mode of study for your subjects or programme, you can visit your classroom anywhere, 365/24/7. The student portal gives you access

to your study materials, where you will have access to the resources, discussions, and forums that you have enrolled in.

Online

For students studying online, your enrollment period per program is three semesters or nine months. The assignments that are due during this period require dedication and precision. Students must hand their assignments in on or before the due date. The due date for the final portfolio of evidence (PoE) will be in the last semester of your enrollment.

Distance Learning (education)

Students study at their own pace. Students can enroll for distance learning study at PCiBS. Students that are contemplating enrolling in distance learning courses have double the time to complete a program as to the other modes of study (or as specified in the subject and program criteria.

Distance learning students must abide by the prescribed work in their study guides and submit assignments based on their less stringent submission dates. Distance learning students must be able to apply diligent discipline, to keep up with and be able to work on their own. Please note that Distance learning students must complete their studies within the overall program time, which is the standard period times 2., e.g., Online: Bachelor of Business = 3 years; Distance learning: = 6 years.

When selecting the Distance learning mode of study for your subjects or programs, you can visit your classroom anywhere, 365/24/7. The student portal gives you access to your study materials, where you will have access to the resources, discussions, and forums.

Select your major(s) or specialization program under Faculties for Undergraduate or Graduate.

The assignments that are due during this period require dedication and precision. Students must hand their assignments in on or before the due date. The due date for the final portfolio of evidence (PoE) will be in the last semester of your enrollment.

PCiBS uses active learning during the period of study; therefore, the faculty requires that students keep up with the work. All subjects are at university level for the various types of specialization certificates, diploma, associate degree, degrees, post-graduate certificates, post-graduate



diploma, Master's degree, and Ph.D. Faculty members have listed their recommendations below for online and distance education students.

Portfolio of Evidence (PoE)

One subject is the Portfolio of Evidence (PoE) that is due for each level of study. The PoE forms part of specific subject assignments that must be completed throughout each course. Together these assignments will include a comprehensive PoE that produces an outcome that will develop the student's competencies in various knowledge areas. The PoE is a 7 to an 8-month long assignment, which forms part of all the building blocks required for performing work in the workplace for the program you are studying. This means that when you have completed this program, you will be able to easily access a job and start working on a very productive basis from day one. The program that PCiBS has developed ensures that active learning is utilized to its fullest and prepares you for the role that you are studying for.

As the level of study increases, so do the competency requirements for the roles you will step into, and the assignments will assist in getting you work-ready. The PoE gets more complicated as the level of study progresses.

Payment options

Our Administration department tries to make life easy for students when it comes to payment. We do not want you to stress about your course fees as there are various methods of payment available.

Students have quite a few payment options available to them.

- Use a credit card or PayPal to pay for your study fees on our secure website via www.pcibs.myshopify.com.
- If you are a US citizen, PayPal offers students a six-month payment plan. Students are responsible for those applications and correspondence with the third-party.
- Using PayPal for payments does involve fees.
 Paypal adds these fees to your account at checkout. See PayPal fees for more information.
- Pay the complete program fee before or on the due date. A tremendous discount is available for this transaction.
- Pay for the subjects per semester on the due date. Online students can stagger their payments over six months. Enrollment must be before or on the deadline prescribed for the program.
- Pay for the subjects per semester on the due date. Distance learning undergraduate & graduate students can stagger their payments over 15 months. Enrollment must be before or on the deadline prescribed for the program.
- Apply for a Scholarship or Commonwealth assistance. There are only a few available, and students are required to enroll as soon as possible.
- All funds must be cleared in the PCiBS' account to ensure that you receive the desired discounts and access to the LMS of PCiBS.
- If you are a potential or existing student, the information we provide on fees gives you all of the details you need about paying your course fees here.

Other student costs

Studying involves mainly tuition fees, but there are additional costs to consider as well. Purchasing **books** will be required for each subject. PCiBS makes sure that we get the best deal for our students.

Application Fee

There is **no** application fee.

Enrollment Fee

There is an **enrollment** fee of USD 55.00. This fee is payable when submitting all the required personal registration information and your academic transcripts and other required data. This will from part of your tuition costs!

Service Fee

There is an Administration department **Service** fee of USD 30.00 charged per subject registration per enrollment period. The service fee does not utilize any discounts, scholarships, or bursaries that are received by the student.

RPL Fee

The cost is USD 35.00 for an RPL unless there is an issue with the transcript or the certification thereof.

Applications for recognition of prior learning (RPL) are handled separately from the enrollment as it requires an entirely different process of verification. PCiBS does accept your previous submissions electronically, but if there should be a concern with the transcript or the certification thereof, a third-party verification/proof will be required. The PCiBS Administration department will manage all RPL applications.

Payment of Student Fees

The student fees apply to the program or subjects that you enrolled in. The payment of your course fees is due after the enrolment process is completed and students are accepted by the PCiBS Administration department.

An "offer of admission to study" will be sent to you for acceptance. Once the PCiBS Administration department receives the "electronically" signed approval, PCiBS will register you as a student with a student number.

A link will be e-mailed to you to make your course or program payment. Please use your allocated student number as a reference. If this is not done, it creates unnecessary delays in the enrolment and registration process.

Recognition of prior learning

Any prior learning can be used for Credits or Exemptions for any course.



APPLICATIONS for CREDITS

Application for Recognition of Prior Learning (RPL) will support access to higher education for future students. They have gained (some hands-on experience) degree-related knowledge and skills through informal study. PCiBS provides prospective students an opportunity to identify their previous learnings, aligning them with the current requirements of their study, and get formal acknowledgment for prior learning. PCiBS looks at the knowledge that is acquired through formal and informal means. Knowledge gained through non-formal education, experience through working will also be considered as part of the RPL process.

The academic faculty / department decides on credit(s)/exemption(s).

You can mitigate this by applying to perform the **Talent Analysis** and get guidance from the experts around this application and the successful outcome of an academic qualification.

Application requirements

Admission requirements for Undergraduate:

- Age: Minimum age 18 years
- Recognition of Previous (RPL) Study: All documents need to be certified/notarized. All non-English documents must have a certified and evaluated English translation attached to the application.
- English level: For non-English speaking students, TOEFL / IELTS or equivalent is required for students who did not study at English speaking schools. You can do your free practice test here. The Admission Committee will also consider factors such as TOEFL/IELTS scores.
- One passport-size photo.
- Passport copy / national ID card certified / notarized.

All PCiBS' programs are conducted in English, and all correspondence will be in English.

Admission requirements for Post- graduate Diploma or Master's Degree:

- Any Bachelor's Degree from a recognized institution
- A professional qualification that is equivalent to a diploma/degree and a minimum of two years of working experience

OR

- Previous work experience in the field of Project Management (minimum 5 years) demonstrated through a CV
- Two letters of recommendation by your peers to start your post-graduate studies explaining your experience and why you would undertake to begin these studies.

PLUS

- Recognition of Previous (RPL) Study: All subjects/transcripts documents need to be certified/notarized. All non-English documents must have a certified and evaluated English translation attached to the application.
- English level: For non-English speaking students, TOEFL / IELTS or equivalent is required for students who did not study at English speaking schools. You can do your free practice test here. The Admission Committee will also consider factors such as TOEFL/IELTS scores.
- One passport-size photo.
- Passport copy / national ID card certified / notarized.
